After review of the October 27, 2011 minutes Andy made a motion to approve and Dennis gave a second. Motion passed unanimously.

Dennis made a motion that the remaining \$2,600 in the tree trimming budget be used to trim as many trees as possible for that amount. Andy gave a second to that amount and the motion passed unanimously. Dennis agreed to have it completed.

ARC members were not present. Jason Gamel reported he would have the new rules and regulations review completed by the next meeting so they could be adopted. Rex was asked to get all the paint book information back from the committee and to then contact color Wheel to expedite the paint book for the community. The Board discussed that Rich Newman had volunteered to be on the ARC. Dennis made a motion that Rich be appointed to the ARC committee. Andy gave a second and the motion passed unanimously. The ARC now includes Blakely Meyers as Chairman, Mickey Shriver, and Rich Newman.

Rex Bowman gave the managers report.

- 1. Financial report for December shows total assets of \$142,770.51 with \$107,529.22 of that amount in reserves. The delinquency report shows as of 12-31-11 the total delinquency is \$3,596.86. As of today 1-24-12 (a new quarter the total amount is \$5,406.32. The amount of Cash in our account today is \$47,219.74.
- 2. Other options for yard sale sign were investigated and company said this is what most communities used. Price for double sided with frame is \$66.00 each.
- 3. Quotes to repair items (street, sidewalk, fence, etc) found by the engineer report were given to Board members for consideration. Rex was asked to contact Asphalt Preservation for more information on what they found more than was showing on the Engineers report. Rex also agreed to contact the engineer to find out his thoughts on items found over and above what he found.
- 4. Manager worked with the gate company to resolve issue of best font for the job. They say they can cut any letters the board decides on since they have a cad system.
- 5. The black painting requested has been completed on both the new sign and the bike rack.

Main Gate repair/replacement was discussed by the board. The board agreed the font options from the gate company did not meet the standards they require. Andy said he had a person that was an expert and wanted permission to have some options drawn. Board agreed that was the best idea to get the proper font. Andy agreed to do it.

The tennis court repair quotes were reviewed. Dennis made a motion to use Elite Court to repair the court and replace the net. Andy gave a second and the motion passed unanimously. Rex agreed to contact them to get the job started.

The play park was discussed and several new items were considered. Andy made a motion
